Since 2005, CASA (Court Appointed Special Advocates) of Rock County has been recruiting ordinary people from all walks of life to become trained volunteers who step up to assist judges and serve the county's most vulnerable children.

We believe in the rights and dignity of children. We are committed to putting that belief to work for children who have experienced abuse or neglect. And we hold ourselves to the highest standards of excellence in service. Across Rock County today, we serve more than 100 children. Close to a hundred more children need our help.

We are there for the child. Whatever their age, children removed from home because of abuse or neglect face a frightening, profound unknown.

We are there to help improve the lives of children and to ensure they reach safe, permanent homes and loving families. And we do.

# A MESSAGE FROM OUR DIRECTOR

Dear Friends,

As we close the door on this most unusual and challenging year, we are filled with gratitude for the heroic efforts of our volunteers, the unwavering support of our donors and the dedication of all our peers in the child welfare system – all who are dedicated to improving the lives of child abuse and neglect victims.

Effective advocacy for vulnerable children and families is difficult work, even under normal circumstances. It takes courage and passion to be a CASA volunteer. Working with child victims of abuse and neglect and the trauma they have endured is often heartbreaking. Speaking up isn't always comfortable, and our advocates must be persistent and tenacious as they investigate the complexities of each case. All of our advocates are instilled with the hope that CASA's voice will help rewrite each child's story and ensure their way to a safe and nurturing home.



This year, COVID-19 forced us to rethink the way we do just about everything, and as you will see in the pages that follow, CASA of Rock County adapted and our volunteers, once again, exceeded our expectations. True to form, they quickly found creative and innovative ways to safely visit their CASA "kiddos" and families. Between March and December, our volunteer advocates logged 2,663 case hours, and on behalf of the 114 children served, submitted 103 reports to the court. CASA often refers to our volunteers as "heroes," and during this crisis, they proved worthy of this distinction.

We are humbled by the steadfast dedication of our volunteers, stakeholders, and generous donors. Thank you for caring about children who can be easily forgotten. Through your time, support, and financial contributions, you demonstrate that they truly matter.





# A YEAR IN REVIEW

#### PINWHEELS FOR PREVENTION

Every April, to commemorate Child Abuse Prevention and Awareness Month, CASA of Rock County holds the Pinwheels for Prevention Event at the courthouse. Over 3,000 pinwheels are planted, one for each report of child abuse or neglect in our county each year. The pinwheel symbolizes the innocence and promise of a happy future all children deserve. Because of Covid-19 the outdoor event was canceled and instead, we planted a Virtual Pinwheel Garden with the help of many friends and supporters.





#### VIRTUAL VOLUNTEER TRAINING

We started off 2020 with our first volunteer training in February. However, as Covid-19 transformed our world, we adapted to create our first virtual volunteer training. Through our virtual trainings this year, we swore in 12 new volunteer advocates! We created Zoom continuing education trainings for our current volunteers to continue our "always learning model".

Along with the virtual volunteer trainings, we learned how to advocate for our kiddos virtually and from a distance. We are so grateful to have committed volunteers who adapted to virtual visits and found creative ways to stay connected to their cases.

#### **HOLIDAY WISH LIST**

Our favorite event of the year is our Holiday Wish List Gift Drive. With the help of many generous donors, we collected personalized gifts for 144 kids involved with the Rock County Child Welfare System! Though this year was challenging for many people and businesses, the number of donations made to our kiddos for the holiday season left us speechless! # OUR COMMITMENT TO DIVERSITY, EQUITY AND INCLUSION




